

BY-LAWS of GREAT BASIN YOUTH SOCCER LEAGUE

AFFILIATION

Affiliation

a) Great Basin Youth Soccer League will be affiliated with and subject to the Constitution, By-Laws, Policy & Procedures and Rules and Regulations of US Club Soccer and US Soccer Federation. GBYSL will also be affiliated with any recognized organization within FIFA.

Amendments to Articles of Incorporation, These By-Laws and the Rules of the League

A) Changes by the Executive Board Necessary to Conform to Nevada or Federal Law. The Executive Board, acting at any regular meeting, may amend the Articles of Incorporation or the By-Laws if such amendment is reasonably believed by the Executive Board (upon advice of an attorney or certified public accountant) to be necessary to conform to Nevada law regarding non-profit organizations, or Federal Law regarding tax-exempt status or charitable status, or if such change is required by US Club Soccer. GBYSL is a private non-profit organization as recognized by the IRS, therefore, not subject to open meeting laws as per NRS 241.

B) Right of Executive Board to Change Articles of Incorporation or By-Laws. The Articles of Incorporation or these By-Laws may be amended by a quorum of the Executive Board at any meeting if:

1. Notice of the proposed change is given in the notice of the meeting.
2. There must be a quorum of the Executive Board and at least simple majority must vote for approval.

Other Meetings, Actions without Meeting Not Authorized pursuant to adopted policy of GBYSL. Executive Board members may call for an emergency meeting according to the established rules and policy.

Other membership meetings and actions by members without a meeting (NRS 82.276, and 82.326) are not authorized.

Rights of Community to Inspect Books and Records

GBYSL will make the most recently filed 990 available for inspection in accordance with NRS 82.186.

Indemnification of Directors and Officers; Liability Insurance

In the event that a director or officer is sued in connection with his or her decisions or activities in furtherance of League business, the Executive Board may agree to pay attorney fees and costs of defense of the action in advance and may agree to indemnify the director or officer for judgments incurred, to the extent allowed by Nevada law at the

time the suit is commenced. The Board may also purchase liability insurance for directors and officers.

CERTIFICATION OF BY-LAWS
